The Embassy of the Arab Republic of Egypt in Hanoi presents its compliments to the Ministry of Agriculture and Rural Development and the Ministry of Education and Training of the Socialist Republic of Vietnam, and has the honor to inform the Latter that the Egyptian International Center of Agriculture (EICA) will hold the following courses in 2019:

1. Food Processing from 15/1/2019 – 31/3/2019
2. Empowering Rural Women from 15/1/2019 – 31/3/2019
3. Vegetable Production from 15/2/2019 – 30/4/2019
4. Integrated Pest Control and Cotton Production from 1/4/2019 – 15/6/2019
5. Project Analysis from 1/4/2019 – 15/6/2019
6. Poultry Production and Health from 10/7/2019 – 25/9/2019
7. Integrated Rural Development from 10/7/2019 – 25/9/2019
8. Animal Production and Health from 1/10/2019 – 15/12/2019
9. Soil and Water Management from 1/10/2019 – 15/12/2019
10. Fish Culture Development from 1/10/2019 – 15/12/2019.

In this connection, EICA would like to offer the Vietnamese side five scholarships within the above-mentioned programs.

The candidate must meet the following requirements :

- Having a good command of one of the following languages: English, French or Spanish.
- Having graduated from an Agricultural University with experience of at least 3 years in the field of related program.
- Presenting to the Embassy a copy of his/her passport.

- Presenting a medical certificate proving that he/she does not carry any infectious diseases and proving his/her medical fitness. The candidate will have a medical check immediately after arriving in Egypt.
- Presenting a report on the nature of his/her work in the related program in the first week of the course.
- The age of the candidate should not be above 40 years old.

In this concern, EICA will cover the following expenses for five candidates in five different courses or five substitutes :

- Two-way ticket (Hanoi - Cairo and vice versa),
- Full accommodation during the period of training course,
- Pocket-money of 50 Egyptian pounds per day.
- Medical care for urgent cases except dentistry.

The candidate are responsible for any expenses (except his travel ticket) during his trip to and from Egypt; and EICA is not responsible for any expenses outside the border of Egypt.

The nominees are requested to arrive in Egypt no later than 3 days before each course.

The Vietnamese side is kindly requested to present candidates for each selected programme for the Embassy's interview.

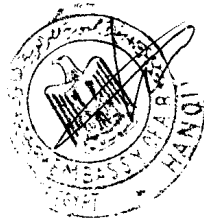
If the Vietnamese side wishes to send any more nominee, they will bear their air-fare, other expenses (accommodation, training expenses, medical care) will be paid by EICA as mentioned above.

In case the nominee terminates the training course before the end of the course, they shall have to pay the return ticket by themselves. The nomination list should be sent to the Embassy at least 1 month in advance.

If any nominee who has been selected by EICA and issued with an air-ticket, cancels or changes his scholarship, the Vietnamese side (Ministries) shall be responsible to collect the ticket cancellation fee of 50USD from those nominees who regret for following the course, to pay the Egyptian side via the Embassy .

If more than one apply for the same course, priority order (A, B, C, etc.) should be specified in the nomination list.

The Embassy of the Arab Republic of Egypt in Hanoi avails itself of this opportunity to renew to the Ministry of Agriculture and Rural Development and the Ministry of Education and Training of the Socialist Republic of Vietnam the assurances of its highest consideration.
